RE: Chemical Resistance testing for SPD Protector.

Lythic Solutions generated concrete samples that were diamond polished to 400 densified with Lythic Densifier, and sealed with Lythic SPD Protector. The samples were tested by Professional Services Industries, Portland Oregon, for chemical resistance with liquids known to stain and etch polished concrete floors. Our intention was to prove that SPD is effective in protecting better than the current acrylic co polymer or waxed based "guard" products that are marginally effective at best.

The results show that SPD Protector will stop penetration of acids and oils to prevent damage previously associated with commercial polished concrete floors.

The test results confirm our expectation that SPD Protector will provide the durability and performance required for floors in commercial and institutional environments to fulfill on the original promise of polished concrete.

Re: Chemical Resistance Testing

This report documents the results of chemical resistance testing conducted on samples treated and submitted by Lythic Solutions. All testing and evaluation was conducted by Professional Services Industries, Inc., (PSI) personnel.

Summary.


Both samples subjected to chemical resistance testing show no signs of permanent staining or damage.

PSI performed a chemical staining study on blocks treated and provided by Lythic Solutions. The type of treatment was not disclosed to PSI at the time of testing, however it was identified after testing as shown in the attached letter. Each sample surface was divided in half with different treatments on each side. The following chemicals were applied to each sample area:


- Motor Oil
- 2. Brake Fluid
- 3. Vinegar
- 4. Red Wine
- 5. Acetone
- 6. Muriatic Acid (30% HCI)


Each block face was divided into six (6) sections. Each section was designated for a set time of exposure (1, 3 and 24 hours) to the above chemicals. 1-3 drops of each chemical were placed in each section. See Picture #1.

After each time interval the designated section was cleaned of its exposed chemical using a dry paper towel. Cleaning consisted of 1-2 simple wipes, with no excessive rubbing. Photographs are shown in Tables 1-3, with observed areas located within approximate blue borders.



White numbered boxes designate chemical type
Blue Boxes designate time interval test areas for 6 chemical types
Green circles indicate hour interval (both side-by-side blue boxes)
Note that each block is divided in half, with different treatments on each side.





Samples were returned to Lythic for cleaning and then returned to PSI for evaluation. The method of cleaning is described as "burnishing with a diamond impregnated fiber pad....". (see attached letter). Both samples show no signs of permanent staining or damage.

Marcel,

For the purposes of filling our your report, I am reporting how we treated the samples PSI tested, and in the case of the samples tested for stain penetration and etching, what we did afterwards to remove the residue and revive the shine.

Sample Prep: Concrete samples for the C501 test were cleaned and lightly abraded with a sanding screen. Lythic Densifier was applied as needed to keep the surface wet for 15 minutes. After drying the top was burnished with a coarse fiber pad and Lythic SPD protector was applied. 24 hours later the surface was burnished. Testing was done after a full cure in 3 days.

Sample Prep for stain and etching tests were processed with diamond tooling to an 800 polish. They were chemically treated with Lythic Densifier and Lythic SPD Protector.

Follow up to stain and etching test was burnishing with a diamond impregnated fiber pad that removed chemical residues and restored shine.

These are all the steps that we took to process the samples tested by PSI.
